WE WORK TO ELIMINATE SYSTEMIC INEQUITIES BY BUILDING A GRASSROOTS ENVIRONMENTAL JUSTICE MOVEMENT IN MARGINALIZED COMMUNITIES TO COLLECTIVELY RESTORE COMMUNITY HEALTH AND ECOLOGICAL BALANCE. OUR WORK STARTS WITH COMMUNITY-LED ORGANIZING, LEADING TO LEGAL, REGULATORY AND POLICY VICTORIES THAT END DAMAGING ENVIRONMENTAL PRACTICES AND REDUCE LEGACY POLLUTION. WE INITIATED LEGISLATIVE ADOPTION OF OREGON'S JOINT RESOLUTION ON AN ENVIRONMENTAL JUSTICE FRAMEWORK AND INTRODUCED THE CONCEPT FOR EQUITY CRITERIA IN LAND USE.
