WE WORK TO ELIMINATE SYSTEMIC INEQUITIES BY BUILDING A GRASSROOTS ENVIRONMENTAL JUSTICE MOVEMENT IN MARGINALIZED COMMUNITIES TO COLLECTIVELY RESTORE COMMUNITY HEALTH AND ECOLOGICAL BALANCE. OUR WORK STARTS WITH COMMUNITY-LED ORGANIZING, LEADING TO LEGAL, REGULATORY AND POLICY VICTORIES THAT END DAMAGING ENVIRONMENTAL PRACTICES AND REDUCE LEGACY POLLUTION.
