**Position Overview:** The **Climate Justice Grassroots Organizer** will work as staff for both Beyond Toxics and the Eugene-Springfield NAACP to serve as the policy and political voice of community members in Lane County, Oregon advocating for climate justice and resiliency, decarbonization and green energy, environmental protections and social and economic justice.

### **Job Description Overview**

The **Climate Justice Grassroots Organizer** will serve as the policy and political voice of community members in Lane County concerned with climate change, social and economic justice. Your main role is to use your knowledge, passion and integrity to develop community leadership for climate action; advance strategic and community-led projects; and provide recommendations to elected officials, local government departments, and other divisions regarding climate action initiatives. The Climate Justice Grassroots Organizer will also manage various projects related to climate resiliency, adaptation and mitigation strategies and education. The person we hire will be formulate equity considerations to empower community and elected leadership to make informed decisions to elevate the social and environmental impacts of climate policy around the county and state. We welcome a self-directed and dynamic individual who is committed to creating a culture of justice, diversity, equity, and inclusion. The person we hire is confident in communicating this culture to the general public, foundations, business leaders, decision-makers and other institutions that make relevant climate justice policies.

## **Qualifications and Skills**

The ideal candidate will be an effective, culturally appropriate and innovative organizer. The candidate should demonstrate knowledge and skills that advance equity, racial and environmental justice policies and a Just Transition Framework in natural resource and climate policies. The candidate must have solid community organizing skills to assist the Executive Directors develop a statewide environmental and racial justice vision and movement.

## **Primary and Required Skills:**

- At least two years of community organizing experience.
- At least one year of field organizing experience including canvassing.
- Experience and competency working with people of various social, cultural, economic, and education backgrounds, including communities of color, Native American Tribes and working-class communities.
- Strong understanding of climate change impacts on frontline & marginalized communities.
- Experience conducting focus groups and group facilitations.
- Experience with policy analysis and communicating best practices.
- Experience event planning and managing and developing coalitions and other strategic partnerships to achieve campaign goals.
- Develop work plans and project tracking systems.
- Experience developing community and youth leadership.
- Campaign leadership experience focused on community outreach and organizing, stakeholder engagement and management
- Experience recruiting and supervising volunteers and interns.

## **Desired Skill Set:**

- Organizational skills including being detail-oriented and able to meet deadlines and establish personal time management.
- Verbal and written fluency in Spanish and/or cultural fluency in non-dominant cultures.
- Experience with volunteer database management programs, Slack, Google Drive, Microsoft Suite, and social media.
- Familiarity with climate or energy policy at the local or state level.
- Strong writing skills able to develop content for reports, testimony at public hearings, semi-annual newsletter, blogs and regular emails to members; other needs as they arise.

## **Salary and Benefits:**

This position is full-time with a starting salary of \$36,400 based on an average of 40 hours a week, and exempt. As exempt, this position is not entitled to overtime pay. Flexibility in hours is needed to support community organizing and events, including evening and weekend work as needed. Benefits include health insurance coverage, 2-week paid vacation and opportunities for paid training and education.
